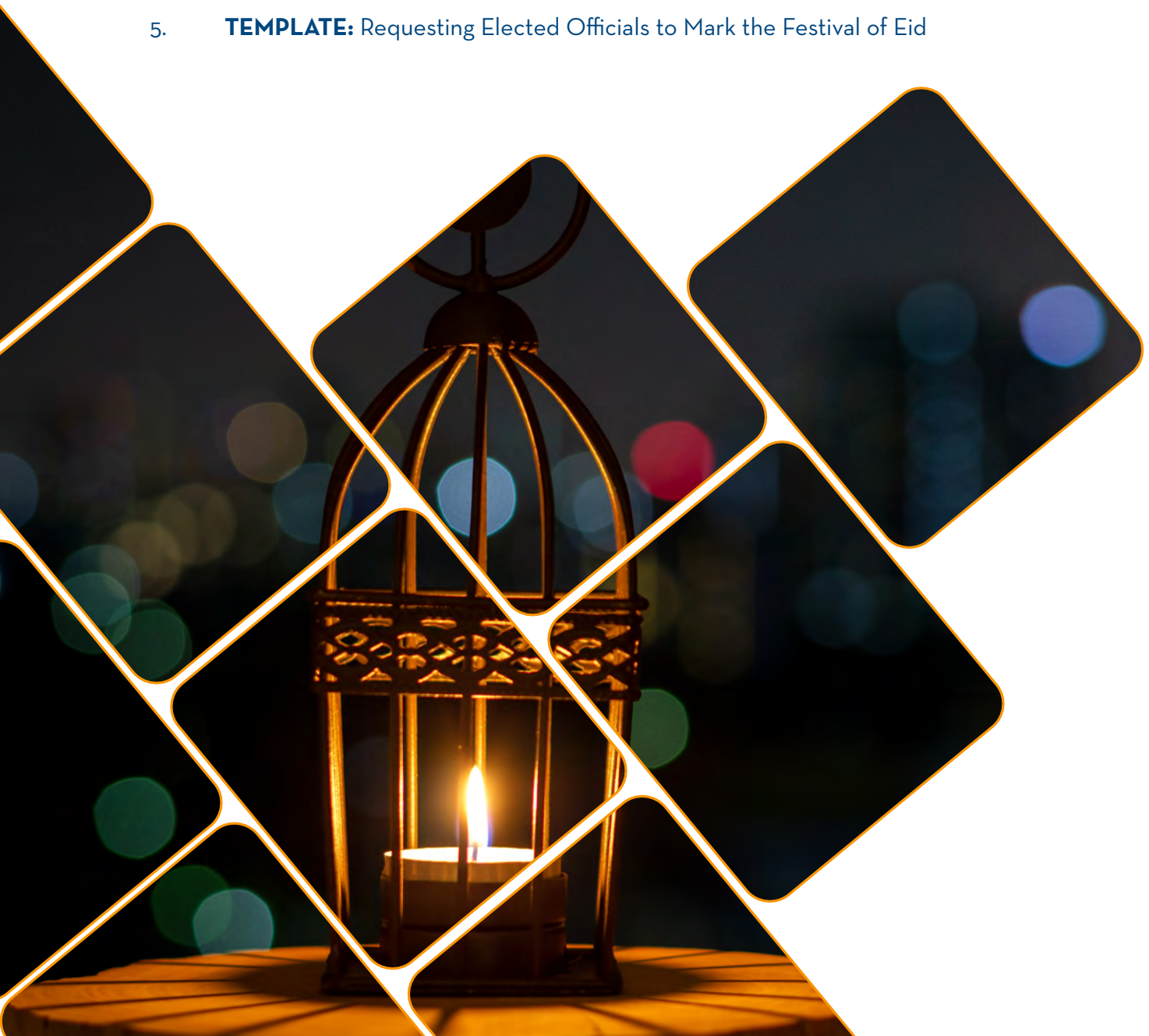

INTRODUCTION

Start of Ramadan

In the beginning of Ramadan: Given that the start and end of Ramadan are determined by moon sightings, there may be variations in opinion among Muslims regarding its timing. Nationally recognized organizations such as the Fiqh Council of North America announce the beginning and end of Ramadan, as well as Eid ul Fitr. Ramadan, observed on the Islamic lunar calendar, involves abstaining from food, drink, and marital relations from dawn to sunset. This year, Ramadan is anticipated to commence around March 11, but exact dates may vary. It is advisable to consult local mosques or Muslim community leaders for precise timings. Eid ul-Fitr, the celebratory “feast of fast breaking” marking the end of Ramadan, is typically commemorated with prayers followed by multicultural bazaars and family activities, often attended by public officials.

Dear ADDRESSEE,

As you may be aware, Ramadan, the holy month of Islam, began at sunset on _____ and will end at sunset on _____. Ramadan is a time for growth, reflection, and community engagement. During this time, Muslims generally observe Ramadan's fast between dawn and sunset and do not drink or eat anything during this time. Further, it is common for Muslims to increase their prayers and charity during Ramadan.

Muslims are also required to observe their five daily prayer times during Ramadan. These prayers fall at: (1) dawn; (2) noon; (3) midafternoon; (4) sunset; and (5) during the evening. While performing the five daily prayers is obligatory for Muslims throughout the year, doing so is especially relevant during Ramadan. These prayers typically take 5-10 minutes to complete and are equivalent to the time usually necessary to take a restroom break. As such, I am requesting to be accommodated for any requests for prayer breaks during Ramadan.

At the conclusion of Ramadan, Muslims celebrate with the Eid ul-Fitr holiday, which is estimated to occur on _____. As the Eid ul-Fitr holiday will occur on a weekday, please be prepared to excuse my absence on that date.

In sum, I am requesting that I be allowed to observe Ramadan according to my sincerely held beliefs. Allowing brief breaks for prayer during the day are reasonable and will not negatively impact any business functions.



My name is [name], and I am the parent of [student name], grade [number], at [school name]. [Student name] is Muslim, and I am requesting an accommodation to make it easier them to pray and fast in accordance with our family's sincerely-held religious beliefs during the month of Ramadan. I am also requesting you provide [student name] with an excused absence on Eid al-Fitr (EED-al-FITTER), or "feast of fast breaking" holiday.

Many school districts across the country work to ensure that Muslim religious accommodations, as required by federal and state law, during Ramadan and the following Eid celebration.

This year, the month of Ramadan will begin around Wednesday, March 27, and end around Thursday, April 20. The Eid al-Fitr holiday, marking the end of Ramadan, is observed on Friday, April 21. Because many Muslims calculate the start and end of Ramadan based on moon sightings, it is common for Muslims to have different Ramadan and Eid start and end dates.

Ramadan is the month on the Islamic lunar calendar during which Muslims abstain from eating, drinking and other sensual pleasures from break of dawn to sunset. It is one of the major Muslim holidays. The second holiday, Eid al-Adha (EED-al-ODHA), is observed on the day of the Hajj, or pilgrimage to Mecca. Ramadan is a time for growth, reflection and engagement. Muslims observe the fast during this time. Prior to fasting each day, Muslims will typically consume a meal called suhoor. The time when dawn begins varies depending on location. The course of Ramadan, as dawn begins at a slightly different time each day, so the time Muslims must finish eating suhoor here: <https://www.islamicfinder.com> (that the website uses your location to calculate times).

Template Resolution Marking the Islamic Holy Month of Ramadan and Eid al-Fitr Holiday

Recognizing the commencement of Ramadan, the Islamic holy month of fasting and spiritual renewal and the holiday of Eid al-Fitr

Template Message to Elected Officials Requesting the Introduction of Local and State Resolutions Marking the Islamic Holy Month of Ramadan and Eid al-Fitr Holiday

Dear **[Elected Official]**,

On behalf of **[Islamic Organization]**, I write to encourage your office to consider introducing a resolution recognizing the commencement of Ramadan, the Muslim holy month of fasting and spiritual renewal, commending Muslims throughout **[City/State]** for their faith and acts of charity.

Traditionally, lawmakers in the U.S. Congress, state legislatures and cities across the country mark the start of Ramadan by introducing resolutions commemorating the month, in addition to issuing welcoming statements, videos and social media.

Many lawmakers and elected officials also introduce resolutions marking the end of the month-long fast of Ramadan and celebration of the Eid al-Fitr holiday.

Muslims calculate the beginning and end of Ramadan and Eid based on moon sightings, so views about start and end dates may vary among Muslim communities.

Throughout the month of Ramadan – which takes place according to the Islamic lunar calendar – Muslims abstain from food, drink, and other sensual pleasures from break of dawn to sunset.

As Muslim communities celebrate and pray together in our houses of worship, we believe it is important for our neighbors to see elected officials nationwide proactively take steps to foster and ensure a greater sense of community and inclusion.

This year **[Islamic Organization]** would like to work with your office to draft such a resolution recognizing the commencement of Ramadan.
